ACWA REPORT

Below is a high-level look at recent ACWA Priority issues, including key legislation that ACWA has advocated for on behalf of its members:

ACWA-sponsored SB 394 – Water Theft:

Authored by Sen. Ben Allen (D-Santa Monica) and co-sponsored by Las Virgenes Municipal Water District, this bill would allow local agencies providing water services to adopt an ordinance with enhanced penalties for water theft from a fire hydrant. SB 394 would help address inefficiencies in current penalties and would establish fines for water theft from a fire hydrant. Additionally, the bill would remove the one-year reset on existing penalties for the third and additional violations for water theft committed via meter tampering and other methods. This bill would also help agencies recover damages by authorizing utilities to pursue civil remedies against any person who tampers with or diverts water from a fire hydrant without authorization. The bill is scheduled to be heard by the Senate Local Government Committee on March 19

SB 454 - PFAS Cleanup:

ACWA is co-sponsoring SB 454, introduced by Sen. Jerry McNerney (D-Pleasanton), in partnership with the League of California Cities. The bill would create a statewide PFAS Mitigation Fund to help local agencies provide safe drinking water and treated wastewater for their communities. If approved, the bill would create a much-needed funding tool to help water and wastewater agencies pay for costs that would otherwise be covered by local ratepayers on their water and wastewater bills. There are currently multiple sources of funding aimed at addressing PFAS contamination (current and potentially future legal settlements, federal funding, state bond funding, etc.) that could be directed to this Fund. SB 454 has been referred to the Senate Environmental Quality Committee. ACWA distributed an Alert asking members to sign a coalition letter in support of the bill.

Water Rights Legislation:

ACWA is advocating on two water rights bills nearly identical to legislation from last year in which ACWA had significant concerns. AB 263 (Rogers, D-Healdsburg) would keep in place emergency regulations adopted by the State Water Resources Control Board for the Scott River and Shasta River watersheds until permanent rules implementing long-term instream flow requirements are adopted. ACWA has an oppose position on the bill because it would set precedent for extending emergency regulations in place of following established processes for emergency regulations in times of drought. AB 263 has been referred to the Assembly Water, Parks and Wildfire Committee. The second bill, AB 362 (Ramos, D-Highland) would define "tribal water uses," designate them as a beneficial use of water and allow tribal water uses to be a primary factor in determining the highest water quality that is reasonable in all regulatory decisions. ACWA has adopted an oppose\(\text{\text{Uniless}} \)

Low-Income Rate Assistance (LIRA) Program:

SB 350, introduced by Senator María Elena Durazo (D-Los Angeles), would require the State Water Board to create a Water Rate Assistance Program to provide financial assistance for both drinking water and wastewater services to low-income residential ratepayers. ACWA believes a water and wastewater low-income rate assistance program — if designed in a reasonable, efficient and effective manner — is an appropriate approach. While SB 350 is a good starting point, the bill can be improved to maximize the funding spent on direct assistance to ratepayers, enhance public process, and reduce unreasonable burdens on water providers. ACWA is urging member agencies to join an association-led coalition to oppose SB 350 unless the bill is appropriately amended to create a workable and efficient LIRA. The bill has been and has been double referred to the Senate Environmental Quality and Energy, Utilities and Communications Committees.

Forest Management and Wildfire:

Orders issued at the state and federal level during the past weekend have the goal of reducing permitting and regulatory barriers that may impede forest management projects aimed at reducing wildfire risk, a key component in enhancing California's headwater health, an ACWA priority issue. Gov. Gavin Newsom on March 1 proclaimed a state of emergency to fast-track eligible critical wildfire prevention projects statewide, ahead of peak fire season. Also on March 1, the Trump Administration released an Executive Order titled, "Immediate Expansion of American Timber Production." This order seeks to increase domestic timber production, calls for legislative approaches to streamline Endangered Species Act reviews to expedite forestry projects, and consider new categorical exclusions for timber production, forest management, wildfire risk reduction treatments, and timber thinning.

Water Measurement and Reporting Regulation:

Last month, the State Water Board initiated the formal rulemaking for the draft Water Measurement and Reporting Regulation (Regulation). The Regulation proposes updates for measuring and reporting requirements for water rights holders that divert over 10 acre-feet per year. ACWA plans to attend the public hearing on April 16 and submit comments by the April 23 deadline.

ACWA Launches Election Process for 2026-'27:

ACWA has launched the election process for the 2026-'27 term for President, Vice President, and region board members. This year, the election process for officers and region boards is now combined. Voting for both sets of candidates will be done electronically by each member agency's designated voter on a single ballot. Agencies can now designate their voting representative by visiting acwa.com/ elections and submitting the Authorized Representative and Information Form by the June 20 deadline.

AB 362 Water Policy: California tribal communities Introduced by: Ramos	This bill is a reintroduction of AB 2614 and is related to California tribal communities and water policy. In short, this bill ensures that tribal water uses are officially recognized as part of the state's "beneficial uses" for water quality protection. This means that tribal water uses must be considered when managing and protecting water quality in the state. Any project or program that affects water quality and requires approval by the State Water Quality Control Board or regional boards must assess its impact on tribal water uses, both with data (quantitative) and descriptions (qualitative). The state must then publish a report on this every two years starting December 2026. SB 72 The California Water Plan: long-term supply targets. Introduced by: Senator Caballero	Senator Anna Caballero (SD-14, Merced) has introduced SB 72. SB 72 would establish long-term water supply targets and call for the Department of Water Resources to use those targets in future updates to the California Water Plan. The bill is a reintroduced version of SB 366 (2024) unanimously pass by both houses of the legislature, and then vetoed by the Governor. SB 366 was supported by the District along with a broad coalition of water agencies, special districts, and associations. According to SB 366's veto message, the bill was vetoed by the Governor due to fiscal concerns at the end of the last legislative session. Since then, the coalition has refined the bill's language to reduce costs associated with its implementation. This bill amends the Porter-Cologne Water Quality Control Act to apply more stringent federal Clean Water Act permitting regulations to former waters of the United States, including incorporating a new category of waters in Porter-Cologne. Dear Committee Member Bauer-Kahan.

West Valley Water District (WVWD) is pleased to support AB 532, which would secure statutory authority for low-income water rate assistance programs and establish the California Low Income Household Water Rate Assistance Program. Since 1952, West Valley Water District has been dedicated to serving the Southern California communities of Bloomington, Colton, Fontana, Rialto, Jurupa Valley and Unincorporated San Bernardino County. Providing water to over 100,000 customers, West Valley is committed to delivering a cost-effective, high-quality water supply. With over half of our customers considered disadvantaged, we fully support AB 532 as it will help our most vulnerable community members.

AB 532 would make significant progress toward Californians accessing low-income water rate assistance. The bill would clarify the statutory authority for urban retail water suppliers, defined as systems serving 3,000 or more connections, to run low-income water rate assistance programs within their communities. The bill additionally includes reporting to the State Water Board that would highlight successes and challenges for the State to offer assistance to the right communities. Lastly, the bill establishes the California Low Income Household Water Rate Assistance Program modeled after the federally funded Low Income Household Water Assistance Program of 2020.

This statutory clarification is necessary for many public water agencies that are ready to offer such programs or are looking for ways to provide support for their low-income customers. Local programs tend to be efficient and effective because they take the diverse needs of the community they serve into account. Within the existing confines of Proposition 218, the authority to offer low-income programs is the first step in providing water rate assistance. The proposed Low-Income Household Water Rate Assistance Program would target systems serving under 3,000 connections where financial hardships are more heavily realized. State assistance for those entities is an appropriate first step in addressing affordability concerns.

Dear State Senator Reyes:

The West Valley Water District (WVWD) is pleased to support your Assembly Bill 259, related to the Ralph M. Brown Act. WVWD is a Special District governed by a five member Board of Directors providing retail water to approximately 101,530 customers. WVWD serves quality drinking water to portions of Rialto, Colton, Fontana, Bloomington, portions of the unincorporated area of San Bernardino County, and a portion of the city of Jurupa Valley in Riverside County.

Recognizing the evolving landscape of public meetings and the demonstrated value of remote participation options when members of governing bodies are unable to attend a physical gathering, your office introduced, and the Legislature passed, Assembly Bill 2449 in 2022, which amended the Ralph M. Brown Act. Beginning in 2023, special districts and other local agencies began using the procedures established by AB 2449, successfully facilitating remote participation for officials that would otherwise been encumbered by illness, official travel, or medical emergency. The provisions of that bill, having been negotiated by civil society groups and local government stakeholders, contained numerous safeguards and requirements, including the presence of an in-person quorum at the official meeting location. In past events, AB 2499 gave our Board Members the opportunity to participate remotely in times of family emergencies, ensuring that their service area continues to be represented.

While the provisions added by AB 2449 were modified slightly by technical amendments made by subsequent legislation, the January 1, 2026 sunset included in the original bill remains. To preserve the flexibility provided by your AB 2449, Assembly Bill 259 would eliminate this sunset date, thereby preserving indefinitely the remote meeting procedures added by the earlier legislation. AB 259 would not otherwise change any other elements of the remote meeting provisions.

Chair Garcia inquired if anyone from the public would like to speak. No requests were received, therefore Chair Garcia closed the public comment period.

III. DISCUSSION ITEMS

1. Updates to the External Affairs Committee.

Manager of Public Outreach and Government Affairs Pantaleon provided an update on congratulatory letters that will be sent out to elected officials after the upcoming election; the filming of a video on the Districts history was completed and staff will receive the first version soon; and the RFP for consulting services for the Water Rates and Prop 218 Process is currently open and closes on November 13th. Senior Public Outreach and Government Affairs Representative Hartley provided an update on Making Conservation a California Way of Life and outreach materials produced. The Committee discussed the State definition of a disadvantaged community and whether the District provides services to those communities. 2. Federal Update.
