ast month, West Valley Water District (WVWD) employee Paul Becker represented our agency at the career fair for the Provisional Accelerated Learning Academy in San Bernardino. Becker encouraged high school students to consider careers in the water industry. "Joining West Valley Water District is a tremendous opportunity for young men and women looking for meaningful, reliable employment in a growing, critical industry," said Becker. To jumpstart conversations about water technology before diving into how WVWD sources and treats water, Becker asked the students questions like: "Who took a shower today?" and "Do you ever think about where that water comes from?" Becker found that most students never considered where their water comes from and were surprised to hear about the complexity and importance of the water industry. "To see them start thinking about water in a way they never had before was such a rewarding feeling," he said. By the

end of the day, Becker had inspired a significant amount of interest in WVWD. He directed these students to apply to WVWD's paid internship program, which just graduated its first class of aspiring professionals. fter a rigorous and transparent redistricting process involving

five public workshops, two public hearings and numerous consultations with community leaders, the West Valley Water District (WVWD) Board of Directors adopted new boundaries for future elections. The new redistricting plan ensures that the board's electoral districts are proportionate to their share of the region's changing population, which has grown significantly. According to recent reports, the Inland Empire, which encompasses San Bernardino and Riverside Counties, is one of the fastest growing population centers in the United States and is now home to a combined population of more than 4.6 million people. So to ensure fairness, transparency and equality for ratepayer representation, the new WVWD redistricting plan is based on the new census data.
