#### STATE WATER BOARD ADOPTS "WASTEFUL WATER" REGULATIONS

The regulations call for the prohibition of wasteful water practices and requires California residents to:

Refrain from utilizing irrigation systems for 2 days after rainfall Apply an automatic shutoff nozzle to water hoses

Turn off decorative water fountains
