II. PUBLIC PARTICIPATION

Chair Young inquired if anyone from the public would like to speak. No requests were received, therefore Chair Young closed the public comment period.

III. DISCUSSION ITEMS

1. Updates to the Engineering, Operations and Planning Committee.

Director of Operations Chan reported on the status of the Fontana Hydrant Retrofit project for which Supervisor Armendarez, Director Moore and General Manager Thiel visited the project site. Ms. Chan also reported that Well 35b is not an active well site and all pump and motor components had been removed, so staff demolished the chlorine building at Well 35b to deter homeless activities.

Director of Engineering Welborn reported that the Water Conservation Specialist's start date is May 27th; staff has received the Bids for the Lord Ranch Project and expects to bring the item to the June committee meeting; Bids will close for Bloomington 3C on June 5th and staff also plans to bring that to the June meeting; and the pipeline project crossing the 15- freeway at Lytle Creek and Citrus performed their exploratory borings and found 30-inch diameter rocks which will likely

result in the need for a larger casing at an additional cost, and a change order is currently being prepared and will be presented to the Committee in June.


